



WAIVER OF LIABILITY

In consideration of being allowed by TT Sports Sdn Bhd (Company No. 534155-U) access into TT Sports Park (hereinafter "the Park") and participate in any way in the paintball games and/or all related events and/or activities in the Park (hereinafter "this activity"), I declare and confirm the following:

1. I am of the **age requirement of 18 years and above.**
2. I am physically fit and have no condition or injury that could or might be affected by this activity.
3. I agree to read and observe the rules of play and regulations of this activity at all times; and that prior to participating, I shall inspect those facilities and/or equipment to be used, and if I suspect or believe those facilities and/or equipment to be unsafe, I shall immediately inform the Park's supervisor of such condition/s and refuse to participate.
4. I acknowledge and fully understand that my engagement in this activity involves risks of serious injury, including but not limited to bodily injury, strains, fractures, partial or total paralysis, eye injury, blindness, heat stroke, heart attack or death, which might result not only from my actions, inactions or negligence but also the actions, inactions or negligence of others, the rules of play and regulations, the condition of the Park and/or any facilities and/or equipment used, whether foreseeable or not.
5. Further, I acknowledge and fully understand that my engagement in this activity also carries risk/s of emotional trauma to my family and friends spectating.
6. Knowing of the foregoing risks, I still consent to my engagement in this activity and expressly agree to assume the foregoing risks and accept personal responsibility for the damage following any such injury, permanent disability, death, emotional trauma and/or damage to property.
7. I hereby voluntarily and fully agree to release, waive, discharge, indemnify and hold harmless TT Sports Sdn Bhd, its owners, directors, agents, officers, employees, other participants, sponsoring agencies, sponsors, advertisers and if applicable, owners and lessors of the Park (hereinafter, "releases") from any and all claims, demands, losses and damages on account of injury, permanent disability, death, emotional trauma and/or damage to property caused or alleged to be caused in whole or in part by the negligence of releases or otherwise, together with any costs including legal fees that may incurred as a result of such claims, demands, losses and damages.
8. I consent to receive medical treatment where deemed necessary by TT Sports Sdn Bhd in the event of injury, accident or illness during this activity and also agree to indemnify TT Sports Sdn Bhd in the event of such medical treatment.
